### **PDT MACRON TO RECEIVE URKAINIAN ZELENSKY**

US Pdt Joe Biden proposed a summit in "a third country" in the "next few months" to his Russian counterpart Vladimir Putin, citing the question of Ukraine and the high tensions between Moscow and Kiev, and discussed the increased Russian troop (80, 000) deployment on the border with Ukraine and a potential summit in a third country. Russia says the troops are there to conduct military drills. Indeed, President Emmanuel Macron is, along with German Chancellor Angela Merkel, mediator in the Ukrainian conflict within the framework of the quadripartite dialogue with Russia and Ukraine (called the "Format Normandie" [?]). The four heads of state met in Paris in December 2019, for the first meeting between Russian President Vladimir Putin and Volodymyr Zelensky after the latter's election in early 2019. Ukraine accuses Russia of having massed new forces near its eastern border and in Crimea, annexed by Moscow in 2014 after pro-Western power came to power in Kiev. The fighting on the front, which was almost at a standstill since a truce concluded in the summer of 2020, has resumed with intensity in recent weeks. G7 foreign ministers and the EU's foreign minister on Monday called on Russia to cease its "provocations" and to engage in "de-escalation". NATO Secretary General Jens Stoltenberg also ruled on Tuesday that the "considerable military strengthening of Russia" [?] was "unjustified, inexplicable and deeply worrying" [?]. For its part, Moscow accused NATO and the United States on Tuesday of turning Ukraine into a "powder keg" and said it was carrying out "military exercises" near the Ukrainian borders.

**READOUT OF PDT JOSEPH R. BIDEN, Jr. CALL WITH PDT VLADIMIR PUTIN OF RUSSIA** -----

« President Joseph R. Biden, Jr. spoke today with President Vladimir Putin of Russia. They discussed a number of regional and global issues, including the intent of the United States and Russia to pursue a strategic stability dialogue on a range of arms control and emerging security issues, building on the extension of the New START Treaty. President Biden also made clear that the United States will act firmly in defense of its national interests in response to Russia's actions, such as cyber intrusions and election

interference. President Biden emphasized the United States´ unwavering commitment to Ukraine´s sovereignty and territorial integrity. The President voiced our concerns over the sudden Russian military build-up in occupied Crimea and on Ukraine´s borders, and called on Russia to de-escalate tensions. President Biden reaffirmed his goal of building a stable and predictable relationship with Russia consistent with U.S. interests, and proposed a summit meeting in a third country in the coming months to discuss the full range of issues facing the United States and Russia. » Source: The White House, 13 April 2021.
